This matter comes before the full court upon the application for interlocutory appeal filed by the League of United Latin American Citizens of Iowa and Majority Forward. Separate resistances were received from Secretary Pate and from the Intervenors-Appellees. In addition, this court has received an amicus brief and several motions for pro hac vice admission.

*Interlocutory appeal.* The court, McDonald and McDermott, JJ, dissenting, grants the application for interlocutory appeal. The parties shall file final briefs in this matter no later than **4:30 p.m. on Friday, October 16, 2020**. No appendix shall be prepared for this

appeal. Any briefs filed may cite to items in the underlying record in lieu of appendix cites. There shall be no reply brief.

The court notes the resistance filed by the intervenors-appellees contain the names of out-of-state lawyers who have not applied for pro hac vice admission in this case. *See* Iowa Ct. R. 31.142)(c) (an out-of-state lawyer must separately seek admission pro hac vice in any subsequent district or appellate court proceedings). The brief filed by the intervenors-appellees shall not contain the names of any out-of-state lawyer who has not been admitted pro hac vice prior to the filing of the brief.

Following the deadline for the filing of the final briefs this matter will be submitted to the court for consideration.

*Amicus and pro hac vice counsel for amicus.* The final brief of amicus curiae filed on October 3, 2020, is accepted as filed.

The motions for pro hac vice admission of attorneys Andrew M. Golodny, Celina W. Stewart, Wendy L. Wysong and Elizabeth C. Arkell are granted.

Pro hac vice counsel is advised that this appeal is governed by Chapter 16 of the Iowa Court Rules pertaining to the court's electronic document management system (EDMS). Pursuant to rule 16.304(1)(b)(1) out-of-state lawyers admitted pro hac vice must complete the EDMS registration process. The clerk shall provide a personal identification number to pro hac vice counsel who have not yet registered at either the appellate or district court. Counsel will need to use the personal identification number to properly register. Pro hac vice counsel is reminded that in the application counsel agreed to be served through local counsel. Until counsel is properly registered pro hac vice counsel shall be served with copies of orders and other filings through local counsel.

Please be advised that in the event oral argument is granted in this case, in-state counsel must be present for oral argument when an out-of-state attorney who has been admitted pro hac vice intends to present the oral argument before the court. *See* Iowa Ct. Rs. 31.14(2)(a), 31.14(3).
